USE CONSTRUCTION PLAN BASED ON INFORMATION AVAILABLE TO US FROM THE CONSTRUCTION. REVIEW USE SUPERVISION, UNUSUAL USE CONDITIONS, AND DAMAGE. EQUIPMENT SHOULD BE PERMANENTLY ANCHORED IN THE FINAL DESIGN. PLEASE VERIFY ALL DIMENSIONS OF PLAY AREA, GROUND PROVISIONS, AND LOCATION OF ALL EXISTING UTILITIES. EQUIPMENT MUST BE SUBMITTED PRIOR TO FINISHING. ACCESS SHOULD NOT FACE THE HOT AFTERNOON SUN.

VERIFY A PROTECTIVE SURFACING MATERIAL THAT HAS A CRITICAL HEIGHT VALUE TO MEET THE MINIMUM FALL HEIGHT FOR THE EQUIPMENT. USE ASTM F1487 STANDARD CONSUMER SAFETY PERFORMANCE SPECIFICATIONS FOR PLAYGROUND EQUIPMENT FOR PUBLIC USE. SECTION 4 CURRENT REVISIONS. THE SURFACING MUST BE WELL DRAINED. IF THE SOIL DRAINS NOT DRAIN NATURALLY IT MUST BE SLOPED OR SLOPED UP TO 1/4" PER FOOT TO A STORM SEWER OR A TRENCH DRAIN.
