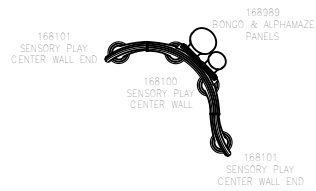

A508 FIBER GLASS REINFORCED POLYESTER
RESIN. VERIFY STANDARD CONSUMER SAFETY
PERFORMANCE SPECIFICATIONS FOR PLAYGROUND
EQUIPMENT FOR PUBLIC USE. SECTION A CURRENT
REVISIONS, THE SUBSTITUTION VALUE AS WELL
DRAINED. IF THE SOIL DOES NOT DRAIN NATURALLY
IT MUST BE TIED OR SLOPED (4% TO 14% FOR
FOOT TO A STORM SEWER OR A TRENCH DRAIN).
